Background:

- 1. <u>Location and Size:</u> The property is located southwest of the intersection of Ames Road and Daisy Drive and is an approximately 0.22 acre tract.
- 2. <u>Current Zoning</u>: The subject property is currently zoned Single-Family Residential (SF-6).

3. Adjacent Properties:

North: Single-Family Residential (SF-6) Developed as Single-Family Residences
South: Single-Family Residential (SF-6) Developed as Single-Family Residences
East: Single-Family Residential (SF-6) Developed as Single-Family Residences
West: Single-Family Residential (SF-6) Developed as Single-Family Residences

Operational Considerations:

This is a request for an exception to the Lancaster Development Code Article 14.503 (A) (3) -Residential Garages and Carports, which requires that "garages must be located off an alley; or if accessed from the front street, must be located at least 20-feet behind the closest corner of the front building facade for front entry garages, unless it is a "J-Swing" garage where the garage door is perpendicular to the street." The applicant is requesting to allow a front-loaded garage that is not setback 20-feet from the front facade of the dwelling. The applicant proposes a front entry garage flush with the front facade.

The protruding front-loaded garage does not enhance the building design and is not compatible with the intended character of the garage location requirement. Additionally, the garage location is not consistent with the City Council's vision for garage locations for residential developments.

Legal Considerations:

This item is being considered at a Regular Meeting of the City Council noticed in accordance with the Texas Open Meeting Act.

Public Information Considerations:

Notice of a Public Hearing was published in the Focus Daily News on September 29, 2022. Notices were sent to property owners within 200' of the request, and a sign was posted. Staff has not received notices in support or opposition to this request.

Discuss and consider a resolution of the City Council of the City of Lancaster, Texas denying the rate change application proposed by Oncor.

Background:

The Steering Committee has been the primary public interest advocate before the Public Utility Commission, the Courts, and the Legislature on electric utility regulation matters for the last 30 years. The City of Lancaster is a member of a 169-city coalition known as the Steering Committee of Cities Served by Oncor (OCSC). OCSC has been in existence since the late 1980s. It took on a formal structure in the early 1990s when cities served by the former TXU gave up their statutory right to rate case expense reimbursement in exchange for higher franchise fee payments.

Oncor Electric Delivery Company ("Oncor" or "the Company") filed an application on or about May 13, 2022 with cities retaining original jurisdiction seeking to increase system-wide transmission and distribution rates by approximately \$251 million or 4.5% over present revenues. Oncor has asked the City to approve an 11.2% increase in residential rates and a 1.6% increase in street lighting rates. If approved, a residential customer using an average of 1,300 kWh per month would see a bill increase of about \$6.02 per month.

On June 13, 2022, City Council approved a resolution to suspend the rate change for 90 days after the date that the rate change would otherwise be effective for any legitimate purpose, which continued to enable the steering committee to engage on behalf of the City for settlement discussions, in preparation of a rate ordinance, on appeal of the rate ordinance to the Public Utility Commission (PUC), and on appeal to the Courts. This time period has permitted the City, through its participation with the Steering Committee of Cities Served by Oncor ("Steering Committee"), to determine that the proposed rate increase is unreasonable. Consistent with the recommendations of the experts engaged by the Steering Committee, Oncor's request for a rate increase should be denied. Negotiating clout and efficiency are enhanced by the City cooperating with the Steering Committee in a common review and common purpose.

A denial of Oncor's proposed increase maintains the status quo until the Public Utility Commission of Texas (PUCT) issues its final order regarding Oncor's rates and provides the Retail Electric Providers (REPs) adequate time to adjust their billings to end-use customers.
