Discuss and consider a resolution extending the term of a Performance Agreement between Lancaster Economic Development Corporation (LEDC) and Dallas College, formerly Cedar Valley College (CVC) from September 30, 2020 to September 30, 2021, in support of a grant to CVC from funds collected from one fourth (1/4) of one (1) percent additional sales and use tax for development of a new Heating, Ventilation and Air Conditioning (HVAC) program provided by Dallas College.

## **Background:**

Cedar Valley College (CVC) intends to develop a state-of-the art Heating, Ventilation, Air Conditioning (HVAC) Commercial program. The program will be implemented at the CVC campus. It will entail a 16,088 s/f facility and the purchase of equipment in the amount of \$615,672.

CVC is requesting to extend the term of the Performance Agreement related to the grant from September 30, 2020 to September 30, 2021 to allow completion of the facility and to amend the agreement with Dallas College (successor-in-interest to Cedar Valley College). A Performance Agreement supporting a grant of \$150,000 for the program was initially approved by the Lancaster Economic Development Corporation on November 1, 2018 and ratified by City Council on November 18, 2018. The creation of the program and completion of the building were delayed due to the COVID-19 pandemic and related social distancing guidelines adopted to help prevent the spread of the virus. The HVAC training facility will be operational by September 30, 2021.

Dallas College (CVC) has offered residential heating and air conditioning certificates and degrees since 1995. Over the years, enrollment in this program has increased but hit a plateau. Understanding the stability of the program and wanting to meet the needs of business and industry, Cedar Valley College is dedicated to expanding its existing program with Commercial and Controls option for heating and air conditioning.

The relationship CVC established by being a member of National Coalition of Certification Centers (NC3) has allowed them to explore opportunities with Trane, U.S., Inc. With the help of NC3 and Trane, Cedar Valley College will become a training and certification center of excellence for students, other schools in the region, and the technician service industry, this includes but is not limited to Heating, Ventilation, Air-Conditioning (HVAC) and Controls.

Understanding and meeting the needs of Lancaster and the labor market, CVC will provide a comprehensive HVAC training program that will prepare students for careers in industry positions in the north Texas service area and beyond. These programs will allow students to obtain marketable skills in order to make an above average salary in a high demand industry.

The median salary in North Texas for Heating, Air Conditioning, and Refrigeration Mechanics is \$46,710 (approximately \$22.46/hour) annually with a growth rate of 27.90% between 2012 and 2022. There are currently 7,010 HVAC positions in the DFW area.

The overall estimated cost of the commercial HVAC lab is \$4.8 million. Development of the program must be operational by September 30, 2021. Allocated funds must be used for real or business personal property purchases. Receipts in the amount of \$150,000 for said purchases must be submitted to the City of Lancaster, Department of Economic Development.

# **Operational Considerations:**

The administrative elements of monitoring the incentive agreement are well within the scope of staff activities. This program will benefit our area by providing easy access to training for our citizens in a field that is in high demand and pays approximately \$46,710 annually.

Discuss and consider a resolution authorizing a grant agreement, in an amount not to exceed \$50,000, with Dallas College from funds collected from the one-fourth (1/4) of one (1) percent additional sales and use tax for the promotion and development of new and expanded business enterprises, as authorized by state law.

## **Background:**

Dallas College (formerly Cedar Valley College (CVC)) submitted a request for matching funds to enable the college to purchase a 53-foot customized trailer Mobile Training Unit (MTU) to deliver training at various employer locations. Dallas College intends to use the trailer to provide certificate programs for Industrial Maintenance Technician, Electrical Technician, Mechatronic Technician and Logistics and promote programs in Automotive, Diesel and HVAC.

The total estimated cost of the project is \$515,295. Dallas College is requesting \$50,000 from the Lancaster Economic Development Corporation. This amount represents 9.7% of total project cost.

Dallas College requested the City and Economic Development Corporation (EDC) to participate by allocating funds to assist with real and business personal property to be utilized within the program. The total match for the grant is \$50,000. Other entities requested to participate include: Cedar Hill Economic Development Corporation, DeSoto Economic Development Corporation, and the City of Dallas. In order to be eligible for the grant, Dallas College will be required to meet the following obligations:

- 1. Grant Payment Draw Down- Recipient shall draw down the funds made available by Grantor no later than December 31, 2020;
- 2. MTU Program Inception Recipient shall complete the MTU vehicle and begin instruction or training no later than December 31, 2021;
- 3. Lancaster Resident Training During the first three (3) years of MTU program operation, Recipient will use the MTU program to provide training to at least twenty (20) City of Lancaster residents and/or persons employed within the City of Lancaster, Texas in work fields that pay at least \$45,000 annually, as determined by U.S. Department of Labor Statistics or other metrics acceptable to Grantor; and
- 4. Lancaster Site Visits During the first three (3) years of MTU program operation, Recipient will use the MTU program to visit at least ten (10) industrial, distribution, or other commercial sites within the City of Lancaster to offer training and/or marketing of the MTU program.

Understanding and meeting the needs of Lancaster and the labor market, Dallas College will provide a comprehensive technical training program that will prepare students for careers in Industrial Maintenance, Electrical, Mechatronics, Logistics, Automotive, and Diesel positions in the north Texas service area and beyond. These programs will allow students to obtain marketable skills in order to make an above-average salary in high demand industries.

Allocated funds must be used for real or business personal property purchases. Receipts totaling an amount not to exceed \$50,000 for said purchases must be submitted to the City of Lancaster, Department of Economic Development.

## **Operational Considerations:**

The administrative elements of monitoring the incentive agreement are well within the scope of staff activities. This program will benefit our area by providing easy access to training for our citizens in a field that is in high demand and pays approximately 20% higher than the current Lancaster median income of \$51,628.
